Northern Beaches Hospital 'Beach and Bush' Photo Competition Terms and Conditions ("Terms and Conditions")

1. We are seeking Northern Beaches bush and beach photographs. The winning photographs will be printed 80cm x 120cm at 300dpi or as landscape in a panorama format 1:2 Ratio as 120cm x 60cm at 300dpi.
2. Participation in this competition is deemed acceptance of these Terms and Conditions by the entrant and if the entrant is under the age of 18 years at the time of entry then their parents or guardian are deemed to accept these Terms and Conditions.
3. Information on how to enter the competition forms part of these Terms and Conditions.
4. The competition will commence on 27 June 2018 and closes at 5:00pm on 30 July 2018 ("**Competition Period**").

How to enter

5. To be eligible to enter the competition, entrants must:
 - a. work at Manly Hospital or Mona Vale Hospital; and/or
 - b. be a resident of one of the suburbs of the Northern Beaches district in New South Wales during the Competition Period ("**Eligible Entrant**").
6. To enter the competition, Eligible Entrants need to obtain a NBH Hospital Photo Competition entry form ("**Entry Form**"), during the Competition Period, which can be obtained by downloading the Entry Form from www.northernbeacheshospital.com.au
7. To enter the competition, Eligible Entrants must take a digital photograph following the competition themes Beach and Bush landscapes (referred to in these Terms and Conditions as "**the Work**"). The Work may be in full colour or black and white and may be digitally enhanced. The Work must be a digital photograph and not a digital composition. The Work should be of the competition theme, Beach and Bush landscapes and shouldn't be a portrait of an individual. The Work must be original works taken by the Eligible Entrant.
8. Eligible Entrants must also complete their personal details including name, address, age (if under 18 years of age), contact phone number and email address in the Entry Form (this information, together with the Work are referred to in these terms and condition of entry as "**Entry**").
9. Entries must be submitted during the Competition Period to be eligible to be a winner of the competition, by:
 - o taking a landscape (not portrait) digital photograph which, at a minimum, must be 300 dpi, high resolution and a JPEG file format;
 - o if the photograph contains identifiable people, then obtain the consent of each person who can be identified and if your work is selected then provide a copy of the written consent of each person to Healthscope;
 - o name the photo file and include the Eligible Entrant's name in the file name of the photograph JPEG file e.g. "Sunrise at Manly by Matt Smith"
 - o complete the Entry Form;
 - o email the Entry Form and the Work (in the file format detailed above) to competition@northernbeacheshospital.com.au with 'NBH Photo Competition' in the subject field of the email.
10. Eligible Entrants may enter the competition no more than four (4) times and one Entry Form must be submitted for each individual photograph.
11. No responsibility will be accepted for Entries not completed as detailed herein or for Entries not received for whatever reason. Any costs and expenses associated with entering this competition is the responsibility of each Eligible Entrant.
12. Responsibility for the content of any information or other material submitted in the Entry rests solely with the Eligible Entrant.
13. Entries which are incomplete, incorrect, offensive, defamatory, derogatory, obscene in nature, non-serious or incomprehensible are not eligible to win.
14. If the Eligible Entrant is under the age of 18 years of age at the time of submitting their Entry, then the Eligible Entrant must obtain permission from their parent or legal guardian and include such details in their Entry. By providing parental consent on the Entry, the Eligible Entrant's parent or legal guardian consent to be bound by these Terms and Conditions in their own right and on behalf of the Eligible Entrant and warrant that:
 - a. the Eligible Entrant, so far as possible, understands the statements and obligations in these terms and conditions; and
 - b. the Work is the Eligible Entrant's own original work and has not been copied from any other work.

Judging

15. Judging will be completed by members of the Northern Beaches Hospital Project Team ("**Judges**").

16. The winners will be decided against a set criteria being artistic merit and the creativity of the Entry.
17. The Judges' decision will be final and no correspondence will be entered into regarding the selection process or decisions made.

Prize

18. The prize is the opportunity to have your photograph displayed within the Northern Beaches Hospital and online at www.northernbeacheshospital.com.au for a period of time to be determined by the Judges ("Prize").
19. The winners will be announced on the Northern Beaches Hospital website www.northernbeacheshospital.com.au and an email will be sent to the email address included on the Entry.
20. The Prize is not transferable or exchangeable and cannot be taken as cash, credit or alternate goods.
21. There shall be no financial reward, royalties or compensation paid to Eligible Entrants, or Eligible Entrants who receive a Prize and have their photograph chosen for display or any person who appears in the Work.
22. Each Entry is the property of Healthscope Operations Pty Ltd and therefore the owner of all copyright and other intellectual property and it, including the Judges or any member of Northern Beaches Hospital Team, has no obligation to return any Entry or the Work to an Eligible Entrant or any other person.

General Terms and Conditions

23. The Eligible Entrant grants Healthscope Operations Pty Ltd a royalty-free, irrevocable and perpetual licence to exercise all copyright and other intellectual property rights subsisting in the Work for any purpose and in any manner, including but not limited to reproduction, communication, promotion, adaptation, display and publication of the Work and in any form or media including but not limited to on display at the Northern Beaches Hospital, online (including social media), in presentations, hospital videos, publications and advertising material. This licence includes the right to sublicense the Work without notice to the Eligible Entrant their parent or their legal guardian.

By submitting an Entry, the Eligible Entrant consents to all relevant acts or omissions in relation to any moral rights in their Entry which might otherwise infringe those moral rights and, to the extent permitted by law, waives all moral rights in the Entry. Healthscope Operations Pty Ltd will use reasonable endeavours to acknowledge the Eligible Entrant's name (as stated in the Entry Form) with the photograph if the photograph is displayed at the Northern Beaches Hospital and the Eligible Entrant acknowledges that they will not be acknowledged if the photograph is used in printed or online material, presentations, videos, publications or advertising material.
25. By entering the competition, the Eligible Entrant agrees to be contacted by Healthscope Operations Pty Ltd and any member of the Northern Beaches Hospital Team and agrees to participate in publicity activities as reasonably requested, including being interviewed and photographed for use in marketing and promotional materials without payment or other compensation.

Healthscope Operations Pty Ltd and the Northern Beaches Hospital Team will collect personal information in order to conduct, administer and promote the competition and may for this purpose disclose such information to third parties.
